Day parking is free, but you must provide a signed COVID Waiver for every person in your car.
Everyone is required to have a face mask.

ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID-19

The novel Coronavirus ("COVID-19") has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies have recommended social distancing and have, in many locations, prohibited or limited the congregation of groups of people. DPCS has put in place preventative measures to reduce the spread of COVID-19; however, DPCS cannot guarantee that you will not become infected with COVID-19. Further, attending and/or participating in classes/show activities with DPCS could increase your risk of contracting COVID-19.

By signing this document:

- I agree to abide by any City, County or State guidelines with jurisdiction of the venue/area and follow all health and safety rules and guidelines set forth by the DPCS.
- I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 as a result of attending and/or participating in classes/show activities with DPCS and that such exposure or infection may result in personal injury, illness, permanent disability, and death.
- I understand that the risk of becoming exposed to or infected by COVID-19 at a DPCS class/show activity may result from the actions or inactions of myself or others. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for my decision to attend and/or participate in a DPCS classes/show activities, and any personal injury, disability, illness, death, damage, loss, claim, liability, or expense of any kind that I may experience or incur in connection with my participation in a DPCS class/show activity.
- I hereby release, covenant not to sue, discharge, and hold harmless DPCS its directors, officers, employees, agents, representatives, volunteers, members, vendors, successors, and assigns, and other participants from any and all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating to my attendance and/or participation in a DPCS classes/show activities.
- I understand and agree that this Assumption of Risk and Waiver of Liability Relating to Coronavirus/COVID19 covers any claims based on the action or inactions of myself, DPCS, its directors, officers, employees, agents, representatives, volunteers, members, vendors, successors, and assigns, and participants, regardless of whether a COVID-19 infection occurs before, during, or after participation in any DPCS class/show activity.
- I attest that to the best of my knowledge at the time of entering the venue grounds I do not currently have or recently have had any symptoms of COVID-19, have not had a positive test in the last 14 days, am not waiting for results of a test for suspicion of COVID-19 and have not been in contact with anyone in the past 14 days who tested positive for COVID-19. If any of the above should change prior to my arrival, during my attendance or within 14 days after attending, I will inform the DPCS and proceed accordingly in light of the new information.
