~ IN SUPPORT OF YOUR HEALTH AND SAFETY ~

1. Masks are required to be worn at all times while not at your car. Mask will be worn correctly, in the ring, at all times, to protect the judge and the exhibitors.
2. Setups will be 6-feet away from each other.
3. Temperature checks will be completed prior to grounds admittance.
4. Completed COVID-19 Waiver forms are required prior to grounds admittance.
5. No generators, blowers or fans at any time are allowed on grounds or in the parking area.
6. No ringside seating, even 6 ft back.
7. No unentered dogs will be allowed on grounds.
