

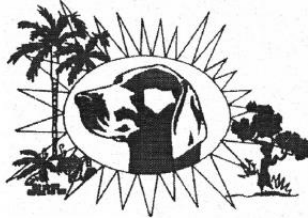

While we would prefer that the show go on, the health and welfare of our exhibitors, judges, members and all those who work to make the show a success is paramount. **Should the show be cancelled due to COVID-19 after entries have been closed, entries will be refunded to exhibitors minus a \$5 per entry processing fee. SWC will not retain any profits after expenses are paid. If a debit or credit card was used for payment, we cannot refund the credit card handling fees.** If we are able to hold the shows, outlined safety requirements will be included with the judging program, and will be based on the AKC Best Practices (available at akc.org), the California State suggested practices, and suggestions from the CDC.

NOTICE TO EXHIBITORS: The American Kennel Club Rules & Regulations will govern this event and exhibitors must make themselves familiar with the agreement on the reverse side of the official American Kennel Club Entry Form which is a part of this Premium List.

COVID-19 (CORONAVIRUS) SOCIAL DISTANCING PLAN SOUTHLAND WEIMARANER CLUB, INC

The following plan is designated at this time for this Event & is posted on www.DogZibit.com. As the situation is continually changing, check back often. Exhibitors are responsible to know and follow the rules listed.

DUE TO CURRENT COVID-19 GUIDELINES & LIMITS SET – IT IS WITH REGRET WE ARE UNABLE TO ALLOW SPECTATORS INTO THE VENUE

Exhibitors should wash hands as frequently as possible. Avoid shaking hands, hugging, or other physical contact. Avoid touching dogs that are not your responsibility. Avoid common use pens/pencils – bring your own. Exhibitors must provide their own scoops for cleaning up from their dogs in public ex-pens & the entire facility. Prepare to be self-sufficient: bring sanitizer, bring personal-use masks.

1. IF YOU ARE ILL, FEEL UNWELL, COUGHING, SNEEZING, HAVE A HEADACHE, SORE THROAT OR RUNNING A FEVER: Please stay home or away from the event.

2. EXPOSURE TO COVID-19: If you have recently been in the presence of a person who has either tested positive for Covid-19 or has the above symptoms (coughing/sneezing/temperature), please stay home or away from the event.

3. STAGING AREA: Depending on the number of entries and dogs in your class. Please remain in this area and maintain social distancing until your number is called to the ring.

4. ARM BANDS: Know the armband numbers for your entries before going to the ring. At the present, the plan is to issue armbands by having a designated table at each ring where the armbands are to be collected, well before your show time and no later than **30 minutes** prior to your scheduled show time. Please know your Armband Number when you arrive at the table. Arrange to pick up all armbands at the same time if possible. Maintain social distancing while waiting for your armbands. Catalogs WILL NOT be available at the tables for your use. If you need to label the armbands for particular dogs, please bring your own pen as pens WILL NOT be available for use.

Do not congregate at the ring or ring gate. While showing your dog, maintain social distances with other exhibitors.

5. RINGSIDE CHAIRS: SWC will not provide for any seating around rings. Exhibitors can bring their own chairs but must maintain 6' social distancing between each other and from the rings. Household units are free to sit together. No group gatherings or congregating at ringside. Chairs may be left at the ring if desired, at the risk of the owners.

6. MASKS: Stewards and Judges will wear masks. Judges will have hand sanitizer and/or gloves available between examinations. All Show Days - Judges & Exhibitors are required to wear a mask while the individual exam of the dog is taking place. Masks may be removed while gaiting your dog. Failure of exhibitors to adhere to this policy could cause them to be excused from the ring and may result in disciplinary action. **FACE SHIELDS do not replace a mask but may be worn in addition to a mask.**

7. EVENT SECRETARY'S TABLE – Exhibitors waiting to be helped must maintain 6 ft distance from the next patron. Forms will be handed out upon request. Exhibitors are required to bring & use their own pen to fill out forms. There will no longer be a “look at” catalog available. Currently, no paper copies of the judge results will be available at the shows. Premium Lists will not be set out for taking.

8. RINGSIDE SETUPS: SWC will allow seating around the rings as long as social distancing 6 ft. apart and masks are worn per CA Covid restrictions. EZ ups will be allowed, which will be back away from the ring and will have to be spaced 6 ft in between EZ ups per Covid instructions. If you have any questions, please ask Bob Margolis.

9. ENTRY TO THE RINGS: Exhibitors will line up outside the ring maintaining social distancing and will be called into the ring as each judge deems appropriate. The judge will direct you as to how to prepare your dog for exam. All Shows – Judges & Exhibitors are required to wear a mask while the individual exam of the dog is taking place. Failure of exhibitors to adhere to this policy could cause them to be excused from the ring and may result in disciplinary action. Follow the judge's directions. When gaiting with other exhibitors, maintain a distance between exhibits. After placements are made, leave the ring and if you are not going forward in the judging of that breed, please leave the ring area. There will be a separate entrance and exit for each ring, please use these appropriately. The judge or steward will direct those who are going forward as to where they are to wait for winners or BOB judging.

VETERAN DOG, 7 yrs and older VETERAN BITCH, 7 yrs and older

*Chapter 11, Sect 8 of the "Rules Applying to Dog Shows" provides: "a neutered male may be entered as a Veteran Dog in the Veteran Dog Class and a spayed bitch may be entered as a Veteran Bitch in the Veteran Bitch Class."

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

NOTE: As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, the dogs or bitches making up the entry judged first in these classes will NOT be eligible to compete for Best of Breed by virtue of having won these classes.

Stud Dog Class - For dogs that have sired two dogs or bitches entered in this show. The award will be based on the merit of the get. The owner of the stud dog need not be the owner of the get. The Stud Dog must appear in the ring with his get and be entered in the Stud Dog Class.

Brood Bitch Class - For bitches that have whelped two dogs or bitches entered in this show. The award will be based on the merits of the produce. The owner of the brood bitch need not be the owner of the produce. The Brood Bitch must appear in the ring with her produce and be entered in the Brood Bitch Class.

**Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."*

BEST OF BREED COMPETITION

The following categories of dogs may be entered in this competition: Dogs that are Champions of Record. Dogs which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of show where a dog completed the requirements for a championship according to the owners' records.

SELECT

When quality warrants, after BOB and BOS are awarded, a Select Dog (SD) and Select Bitch (SB) may be chosen from the remaining Champions (Non-Regular Class winners that are Champions and qualify for BOB are eligible; WD and WB are not eligible). AKC Dog Show Rules, Chapt 3, Sect 14).

AWARDS OF MERIT

After awarding Best of Breed, Best of Winners and Best of Opposite Sex, the judge may award up to three (3) Awards of Merit to exhibits in the Breed ring that are, in the judge's opinion, outstanding specimens. The total number of Awards of Merit the judge is allowed is determined by the total number of dogs competing in Best of Breed competition. 1 Award for 5-8 entries, 2 Awards for 9-14 entries, 3 Awards for 15 plus entries. Each recipient will receive a Rosette.

AMATEUR OWNER HANDLER

For dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog and is limited to exhibitors who have not, at any point in time, been a professional handler, AKC approved conformation judge, or employed as an assistant to a professional handler. Additionally, members of the immediate family or household of a current professional handler are ineligible for this class (as defined in Chapter 11, Section 13). Professional handlers are defined as any person who belongs to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.

BRED BY EXHIBITOR CLASS ELIGIBILITY

All dogs entered in the Bred-By Class must be individually registered with the AKC. The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. Family members must be both a breeder and owner of record to exhibit in the class.

BEST PUPPY

Best Puppy will be selected from the First Place Winners of the 6-9 months and 9-12 months Dog & Bitch classes.

BEST VETERAN

Best Veteran will be selected from the First Place Winners of the Veteran Dog & Bitch classes.

OBEDIENCE CLASSIFICATION

REFUND FOR BITCHES IN SEASON IN OBEDIENCE OR RALLY: Bitches in season are not allowed to compete in Obedience and/or Rally trials. If a bitch comes into season after entries close, the Club will refund the entry fee for both Obedience and/or Rally entries, providing the show secretary is notified in writing of the withdrawal at least 30 minutes prior to the scheduled start of the show/trials. The refund will be issued to the listed owner of the dog/bitch.

JUNIOR SHOWMANSHIP CLASSIFICATIONS

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED:

- **Junior**-9 years old and under 12 years old on the day of the show
- **Intermediate**-12 years old and under 15 years old on the day of the show
- **Senior**-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show.

All dogs/bitches entered in the Futurity or Maturity must be entered in one of the regular or non-regular conformation classes of the Southland Weimaraner Club's Specialty Show on Friday, May 14, 2021. A \$30.00 entry fee is required to enter the Futurity or Maturity after the dog/bitch has been properly entered in one of the regular or non-regular conformation classes. All dogs/bitches entered in the Maturity must have been eligible for a Futurity event. Indicate your dog's Futurity or Maturity Class on the entry form in the space provided for Additional Classes.

Notice: all entries must comply with the WCA Futurity & Maturity Program rules. Exhibitor is solely responsible for knowledge of and compliance with those rules.

Futurity Classification

Senior Dog/Bitch - Born on or after June 1, 2018 through September 30, 2018
Intermediate Dog/Bitch - Born on or after October 1, 2018 through Jan. 31, 2019
Junior Dog/Bitch - Born on or after February 1, 2019 through May 31, 2019

Eligible dogs will be identified by an asterisk in the judge's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants** to professional handlers may not exhibit the dog in this competition.**

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and undefeated winners of the non-regular classes. This excludes all dogs defeated during class and winners competition for the regular show.

- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety.
- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed/Variety nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If Best of Breed/Variety, Best of Opposite Sex to Best of Breed/Variety, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog who competed in Best of Breed/Variety including Winners Dog or Winners Bitch as the Best of Breed/Variety for the AKC National Owner-Handled Series.
- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.
- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.

* Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

**A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.

The Club and/or DogZibit assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner.
2. No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, FAX email, phone and unsigned entries cannot be accepted.
