TURN right on Santiago Canyon Road, TURN right on Jamboree Road, TURN left on East Santiago Canyon Road. TURN right on Cannon Street (turns into Imperial HWY). Take 91 Freeway East for one exit. Exit Weir Canyon Road go North (TURN left). TURN right immediately on Savi Ranch Parkway, TURN left on Mirage, Left on Crystal. ## DIRECTIONS TO THE SHOWGROUNDS

**FROM THE NORTH:** Take most convenient freeway to the 55 Freeway. Exit at Chapman Avenue EAST. Chapman Avenue turns into Santiago Canyon Road. Travel approximately 9 miles from the 55 Freeway. You will pass Irvine Lake on the left (DO NOT turn into Irvine Lake). Make first left after Irvine Lake at park entrance. Follow signs.

**FROM THE EAST:** Take the 91 to the 55 freeway. Exit at Chapman Avenue EAST. Chapman Avenue turns into Santiago Canyon Road. Follow the road approximately 9 miles (from the 55 freeway). You will pass Irvine Lake on the left (DO NOT turn into Irvine Lake). Make first left after Irvine Lake at park entrance. Follow Signs.

**FROM THE SOUTH:** Exit 5 Fwy North at El Toro Road and turn right. El Toro Road turns into Santiago Canyon Road. Travel 15.75 miles to park entrance on the right. (If you reach Irvine Lake, you've gone too far). Turn right turn at park entrance Follow signs.

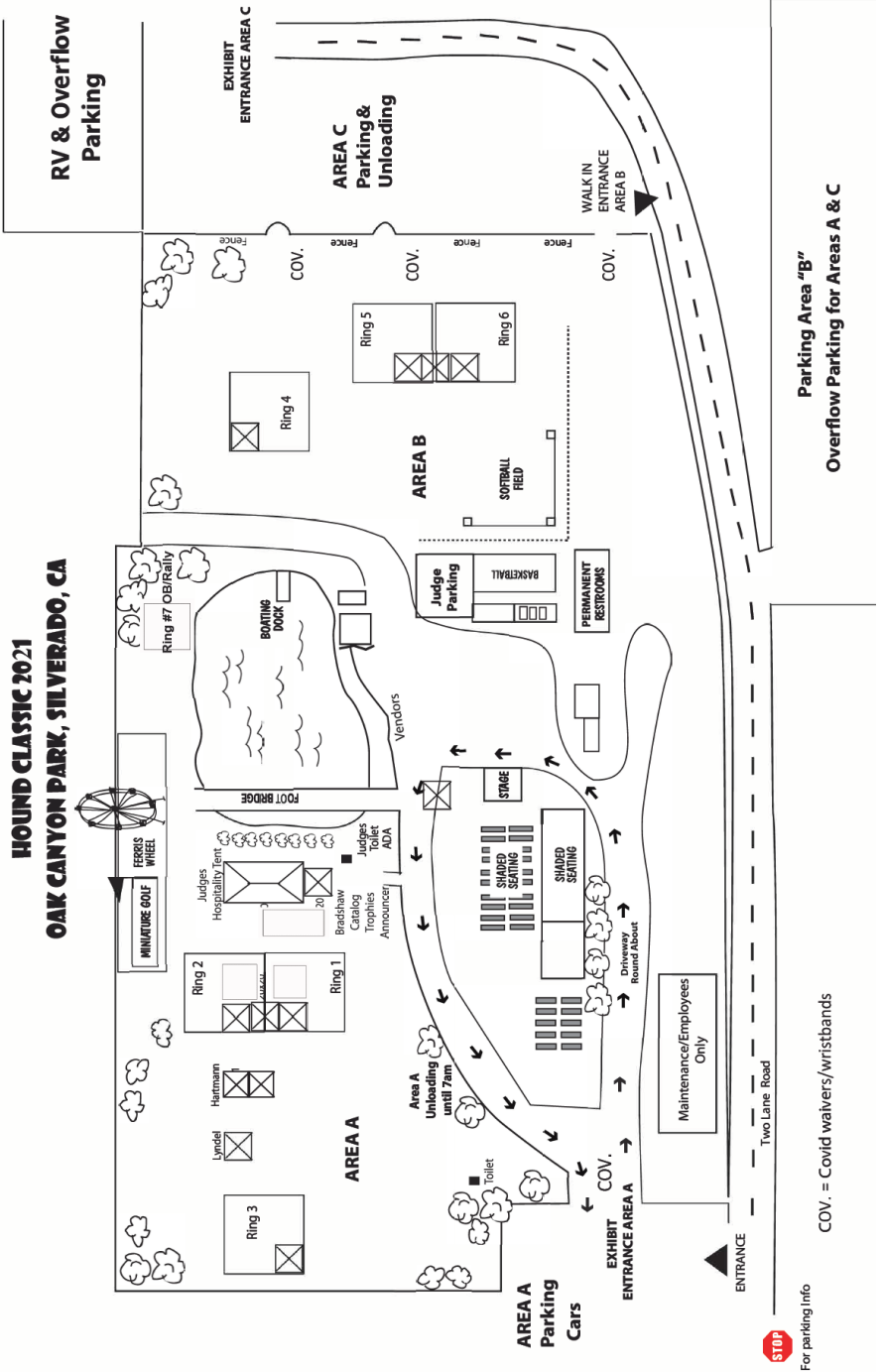
